Terms & Conditions for the Pirates of Port Adelaide 'Treasure Hunt' Competition

- 1. The promoter of this promotion is the PIRATES OF PORT ADELAIDE ("Promoter").
- 2. Information of how to enter the promotion forms part of these Conditions of Entry. Entry into the promotion is deemed acceptance of these Conditions of Entry.
